Agenda Item #5 – Review of Airport Activity and Financial Reports for the Month and Year Ending December 31, 2020 (Rogers and Swanson)

<u>Airport Activity – Air Traffic</u> (Rogers)

The December 2020 air traffic count decreased 7% to 4,269 operations as compared to the December 2019 total of 4,587. December air traffic count is consistently low due to the semester break for K-State flight training. For CY 2020 a total of 60,448 operations were recorded which is 21% less than the December 2019 YTD total of 76,553. The CY 2020 total air traffic decline was due to COVID19. The 2020 air traffic count for all 520, FAA, air traffic control towers was down 22% as compared to CY 2019.

<u>Airport Activity – Fuel Flowage</u> (Rogers)

December 2020 fuel flowage was 114,869 gallons, which was a 32% increase as compared to the December 2019 total of 87,182 gallons. For CY 2020 fuel flowage totaled 2,295,009 gallons which was a

1% increase as compared to the CY 2019 total of 2,278,659 gallons. A sampling of other airports shows fuel flowage decreases in the range of 30% to 40%.

<u>Airport Activity – Passenger Counts</u> (Rogers)

SkyWest enplaned 628 passengers, which was a 66% decrease over the December 2019 total of 1,874 passengers. The airline's total passenger count was 1,168 which was a 68% decrease over the December 2019 total of 3,629. For CY 2020 a total of 7,877 passengers enplaned United/SkyWest flights as compared to the CY 2019 total of 19,710 passenger enplanements. The 60% decrease is consistent with the national decline in air travel during COVID19. The ArkStar CY 2020 scheduled air service review will go into more details concerning 2020 and the 2021 outlook.

<u>Financial Reports – Comments and Notes</u> (Swanson)

The beginning of a new year brings about our usual fiscal year close-out activity necessary to bring you the preliminary December 31 financial statements. In addition to working on tax and informational returns, W-2s, 1099s and other year-end activity, we are pleased to report that all year end accruals applicable to net operating income have been calculated and are incorporated into the preliminary year end financials. This includes items such accrued wages and payroll, long-term debt interest expense, prepaid insurance, dues and subscriptions, and property tax. Year-end work remaining includes the Net KPERS OPEB and pension liabilities (reports are not available from KPERS until January 31, 2021) final depreciation schedule and calculations. Additionally, we anticipate having a few invoices for work that was done in December trickling in between now and the end of January. As is our normal procedure, we will highlight any significant changes from the preliminary statements enclosed in your packet today, to the final audited statements as presented in the CAFR.

The only distribution from bond proceeds during December 2020 was the transfer of the balance remaining (\$112,337.59) from the 2020-1 GO Temp Note fund to the respective debt service fund. This transfer closes out the project (Schwan's Land Transfers) and the balance will be used to retire the temporary notes.

Highlights from the preliminary year ended December 31, 2020 financials include:

- Unrestricted cash in bank at \$1,545,361
- Total income exceeded budget by \$166,202 and beat YOY by 9.23%
- Total operating expenses came in just slightly over budget (\$11,907) and 3.3% more than 2019
- ➤ Net operating income for the year came in at \$224,386, exceeding 2019's NIBD by \$146,856

Of note is that while the increase in leasing activity resulted in income exceeding budget by 7%, the SAA was able to hold operating costs to just \$11,907 over budget.

Short-term leasing activity:

On Dec. 21, the SAA leased Bldg. 1080 (2,277 sq. ft. Morton building) to Central Plains Agronomy for temporary storage of herbicides/pesticides over the winter months. This four-month agreement will generate \$950/month or \$3,800.

<u>Agenda Item #7 – Salina Area Chamber of Commerce Economic Development Services Agreement Update (Rogers)</u>

Since 2028 the Airport Authority has contracted with the Salina Area Chamber of Commerce for economic development services that include assistance with workforce recruitment and housing issues. The Chamber has developed and implemented the *Imagine Salina* campaign that has proven effective in attracting workers to businesses located at the Salina Airport and Airport Industrial Center. The Salina Chamber staff have assisted 1 Vision Aviation management with aircraft mechanic and technician recruitment. Most recently Chamber staff has worked with 1 Vision on the challenge of finding housing for new 1 Vision employees moving to Salina and Saline County. This past week alone 1 Vision onboarded 30 employees who need to find homes in Salina and surrounding area.

Chamber president and CEO Eric Brown will attend the meeting with Renee Duxler, economic & workforce development director, to update you on the outlook for 2021.

<u>Agenda Item #8 – Salina Regional Airport Air Service Development Annual Review (Rogers)</u>

Gary Foss, managing partner for The ArkStar Group will join the meeting to present his annual review of Salina's scheduled air service. Attached is a copy of Gary's December 2020 Salina market review that will serve as a basis for his 2020 year in review. Please note slide #8, page #7, of the slide deck. Between August and November 2020 passengers returned to Salina United/SkyWest flights at a faster rate than the national average. Salina's late 2020 recovery is a good indicator that 2021 will be a better year for passenger enplanements.

<u>Agenda Item #9 – Review of FAA Airport Improvement Grant Funding Available for the Runway 17/35 Rehabilitation Project.</u> (Rogers and Swanson)

The SAA's airport engineering and consulting firm Jviation is making progress on the preliminary design of the Runway 17/35 rehabilitation project. The project's Pavement Investigation Summary Report is close to the final draft stage and ready for review by the Federal Aviation Administration (FAA). The report supports that conclusion that a mill and asphalt overlay of the runway will result in a 10-to-12-year useful life.

The current estimated cost for the project is \$4.8M. FAA AIP grant funds will cover 90% of project costs. Or approximately \$4.32M. The Airport Authority's mill levy for federal grant matching funds will fund the SAA's 10% local share of \$480K.

The FAA Central Region Airports Division has notified me that they will be able to offer the SAA a multiyear FAA AIP grant agreement that will cover the cost of completing the Runway 17/35 design, project bidding and construction over three years (FFY21, FFY22 and FFY23). The multi-year grant can be issued as early as May 2021. This means that project design can be completed during CY21, construction bids obtained in CY21 and construction completed during the Spring/Summer of CY22. A May 2021 multi-year AIP grant agreement will reimburse the Airport Authority for 90% of the cost to design, bid and construct the project.

At our August 19, 2020 board meeting the board authorized the expenditure of \$200,000 for the SAA's airport engineering firm, Jviation to complete Runway 17/35 preliminary design services. To complete final project design and obtain construction bids Jviation's authorization needs to be increased to a total of \$454,378. The pending AIP multi-year grant will reimburse the SAA for 90% (\$408,940) of the \$454,378 lump sum design and bidding fee.

Recommendation: Approval of a maximum expenditure of \$454,378 with Jviation for the completion of Runway 17/35 rehabilitation design and bidding and submit a multi-year FAA AIP grant application for Runway 17/35 design and construction.

Agenda Item #10 - Consideration of a Request from the Board of Trustees for the Salina Area Technical College for the Acquisition of Salina Airport Authority Property. (Rogers)

Enclosed is a copy of a letter from the Salina Area Technical College (SATC) expressing the college's interest in acquiring two SAA lots totaling 3.2 acres located at the Northwest end of Berschell Rd (a location map is also enclosed). The two lots would be used for future expansion of the SATC campus as part of SATC board or trustees plans to expand the college's capabilities to meet local and area workforce education and training needs. A high SATC priority is the construction of a new health science building that may be good fit on the SAA's 3.2 acres.

I would like to schedule SATC president Greg Nichols for a February 17, 2021 board meeting presentation that will provide more details about SATC vision for campus improvements and enhanced educational programs.

Board action is not needed now. Following Mr. Nichols presentation next month, I will prepare response options for your consideration.

<u>Agenda Item #11 – Overview of COVID19 Financial Assistance Available Through the FAA's Airport Coronavirus Response Grant Program.</u> (Rogers and Swanson)

At the meeting Shelli and I should be able to provide you details concerning the most recent COVID19 financial relief legislation passed by Congress. Right now, we know that all primary, commercial service airports are eligible for additional COVID19 relief grant funds. The FAA has not issued new guidance to airport sponsors concerning either the timing for grant agreements or the amount of grant funds that will be allocated to each of the nation's, 522 commercial service, primary airports. We hope to have the FAA guidance in hand by the board meeting.

With additional COVID19 grant funding the Airport Authority will be able to continue to reimburse airport operating expenses and purchase needed airfield equipment. The next equipment priorities are a replacement for our 30-year-old front end loader and a brush chipper. Staff is currently preparing bid specifications for a front-end loader (with attachments) and a brush chipper.

Agenda Item #12 – Aircraft Storage Hangar Construction Design and Bidding Schedule. (Bieker)

At the meeting Kenny Bieker will provide an update on the start of Hutton's design work for new aircraft storage hangars. We held a kick-off meeting with Hutton architects on Monday, January 4. The scope of work for the hangars was firmed up and we added the design of a stand-alone, public restroom to the project. A stand alone, public restroom building will be situated to benefit all GA hangar tenants and be available for use 24-hours per day. Kenny's report will include the timing for completion of the design phase and a probable date for receiving contractor bids.

MINUTES OF THE REGULAR MEETING OF THE BOARD OF DIRECTORS OF THE SALINA AIRPORT AUTHORITY DECEMBER 16, 2020 VIA GOTO MEETING VIDEO AND AUDIO LINK

Call to Order

The meeting was called to order at 8:00 AM by Chairman Alan Eichelberger. Business and Communications Manager Kasey Windhorst completed roll call and confirmed that a quorum was present. Windhorst noted the board meeting notice was published and distributed on Friday, December 11, 2020.

Meeting Procedures

Attendance

Roll call attendance was taken. Chairman Eichelberger, Directors Buer, Gunn, Vancil and Weisel attended via video conference. Executive Director Tim Rogers; Director of Administration and Finance Shelli Swanson; Director of Facilities and Construction Kenny Bieker; Business and Communications Manager Kasey Windhorst and Attorney Greg Bengtson attended via video conference. Mitch Robinson, Salina Community Economic Development Organization and Melissa Hodges, Salina City Commissioner were guests via video conference.

Additions to the Agenda

Chairman Eichelberger asked if there were any additions. Executive Director Rogers stated there were no additions.

Minutes

Chairman Eichelberger asked if the board members had additions or corrections to the minutes of the November 18, 2020 regular board meeting and the December 2, 2020 special board meeting. Director Weisel moved, seconded by Director Vancil, to approve the minutes of the November 18, 2020 regular board meeting and the December 2, 2020 special board meeting.

Roll call vote: Director Buer – Aye, Chairman Eichelberger – Aye, Director Gunn – Aye, Director Vancil - Aye and Director Weisel - Aye. Motion passed unanimously.

Airport Activity and Financial Reports

Executive Director Rogers reported that the Salina Air Traffic Control Tower (ATCT) recorded 5,078 operations during November 2020, which was a 16% decrease compared to the same period last year. A total of 56,179 operations have occurred year-to-date which is 22% less than the November 2019 year-to-date total of 71,966. November fuel flowage came in at 171,011 gallons which was a 57% increase compared to November 2019 total of 108,524 gallons. A total of 2,180,258 gallons have been delivered on the airport during 2020 which is a slight decrease compared to the 2019 total of 2,191,477. United/SkyWest flights enplaned 602 passengers, which was a 65% decrease as compared to the November 2019 total of 1,703 enplaned passengers. The airline's total passenger count was 1,079 which was a 68% decrease as compared to the November 2019 total of 3,340.

Director of Administration and Finance, Shelli Swanson reported on the financials for the month of November 2020. Total operating revenue is exceeding budget at the end of November by \$185,834 and is exceeding 2019 income by 8.61% as a result of year-over-year growth in landing fees, building rental, land rental and other income such as ARFF standby fees and equipment rentals. Total operating expenses are tracking 2% under budget bringing net income before depreciation to \$303,537 year-to-date which represents a 180% increase over 2019. Swanson commented on a short-term lease agreement with Northwest Crane Service for 20,000 SF of pavement located on the north ramp. The rental rate is \$.192 SF/year and will result in additional \$1,1920 in revenue. Chairman Eichelberger directed staff to file the financials for audit.

2021 Operating Plan and Budget

Executive Director Rogers reviewed the final draft of the Airport Authority's 2021 Operating Plan and Budget. Rogers highlighted on the following priorities for 2021.

- Continued fuel flowage growth
- Market available buildings, hangars, and development lots to reach 85% occupancy
- Continue air service development and marketing efforts
- Secure FAA MAP grant funding for terminal building expansion
- Secure FAA grant funding for the Runway 17/35 rehabilitation project
- Support implementation of the K-State Polytechnic Global Aeronautics Initiative and campus vision initiatives
- Complete the Schilling Project remedial design (RD) and start remedial action (RA) work
- Airport Industrial Center development objectives and expansion projects
- Contract with the Salina Chamber for services to meet aerospace workforce

recruitment and workforce housing needs

- End CY 2021 with an ending operating cash balance greater than \$1.5M
- Achieve an occupancy rate greater than 85% for available hangars and building
- Support 2021 FOL deployments
- Support Ft. Riley APOE/D operations
- Complete the design of new GA aircraft storage hangars, secure project financing, prelease units and construction hangars
- Recruit and hire one ARFF& operations specialist and create the new position of assistant manager of operations
- Update the job descriptions for the executive director, director of finance and administration, director of facilities and construction, business and communications manager and operations manager
- Develop a standard environmental report for prospective tenants considering hangar and building available for lease
- Prepare an EDA grant application for hangar H626 rehabilitation

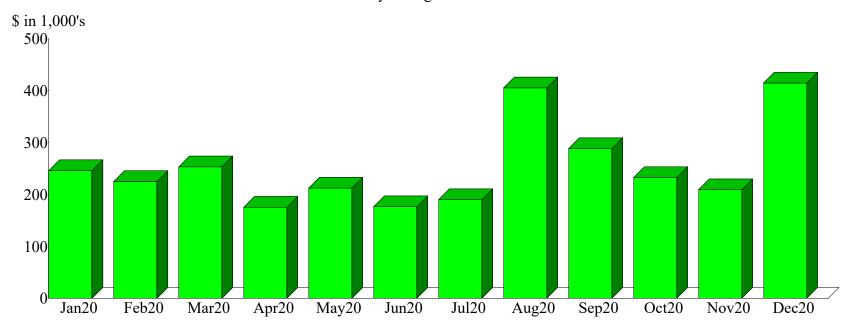

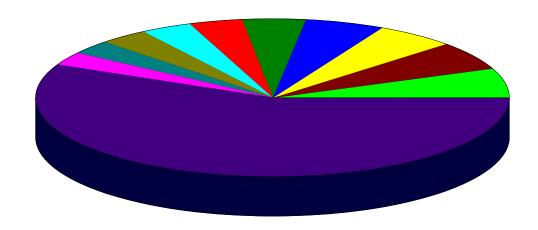

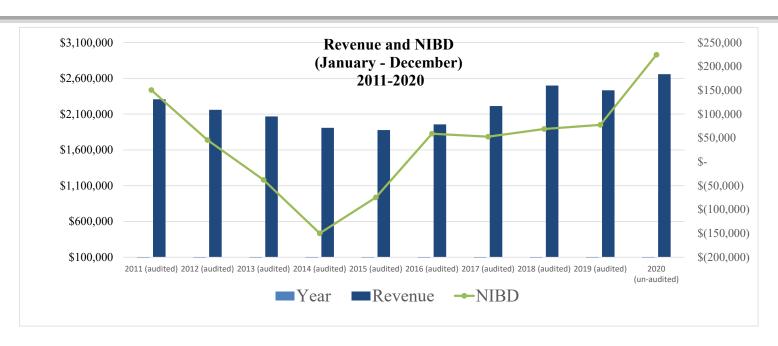

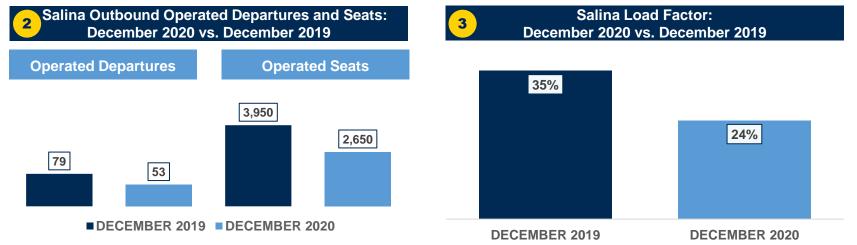

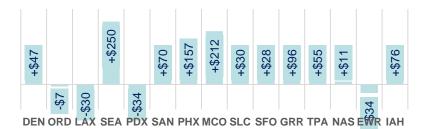

Salina vs. United at Kansas City

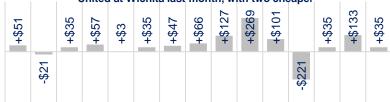

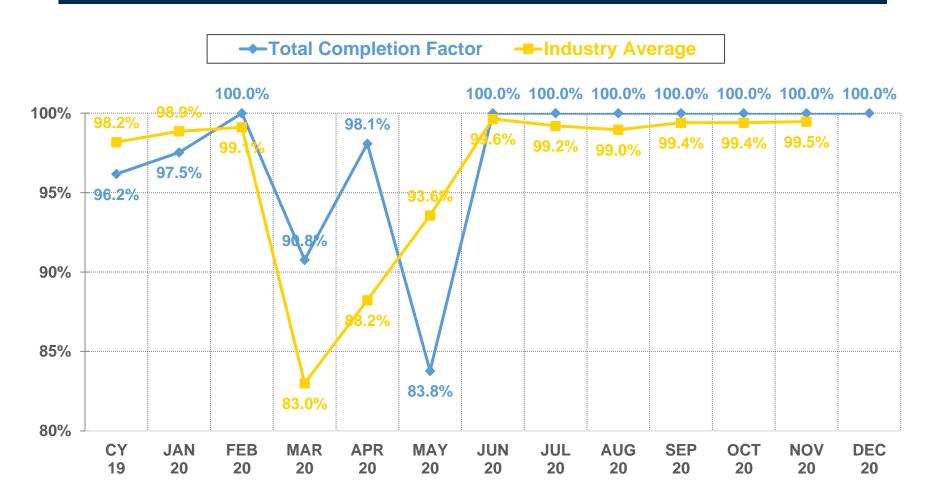

Total Completion Factor (Including Weather) at Salina



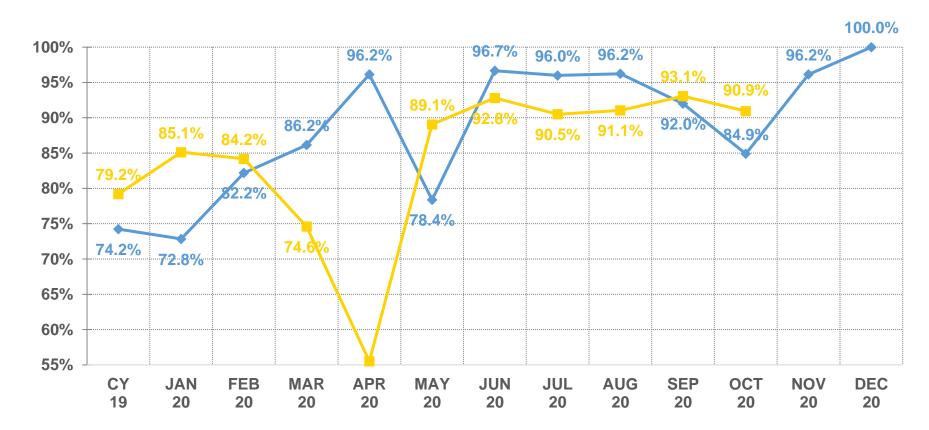

Arrivals at Salina within 14 Minutes

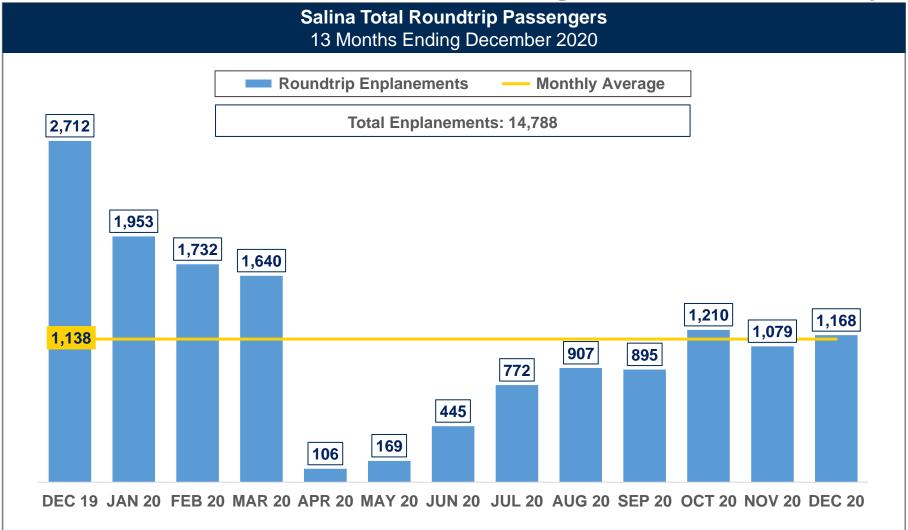

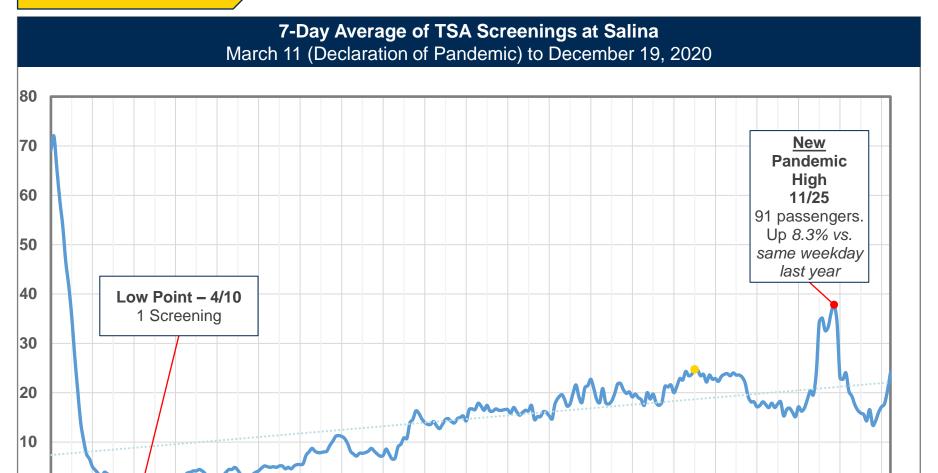

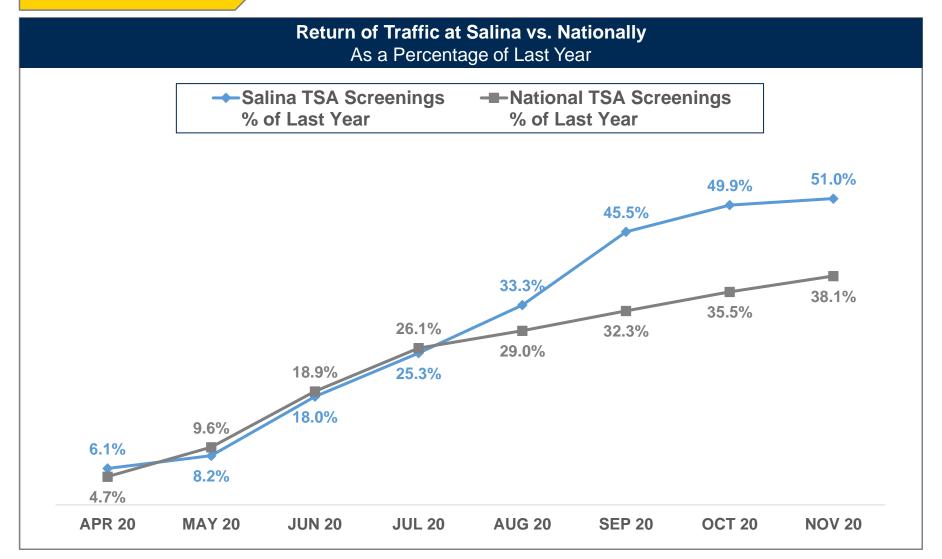

Between August and November, traffic returned to Salina at a faster rate than the national average



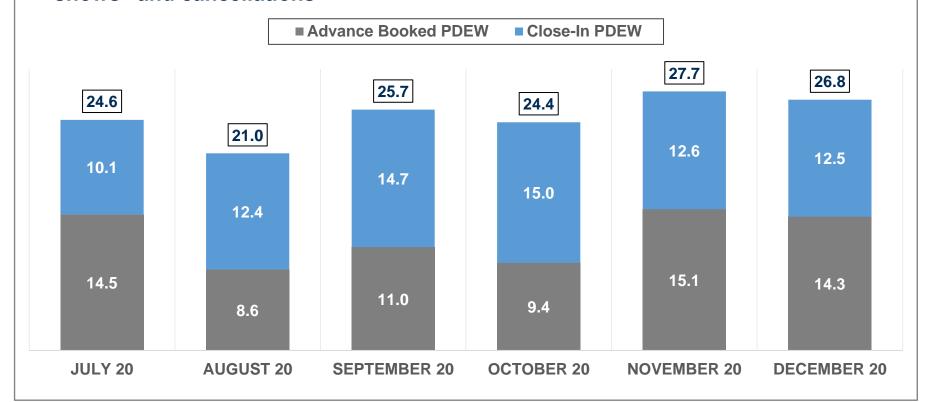

Advanced and Close-In Bookings at Salina July to December 2020

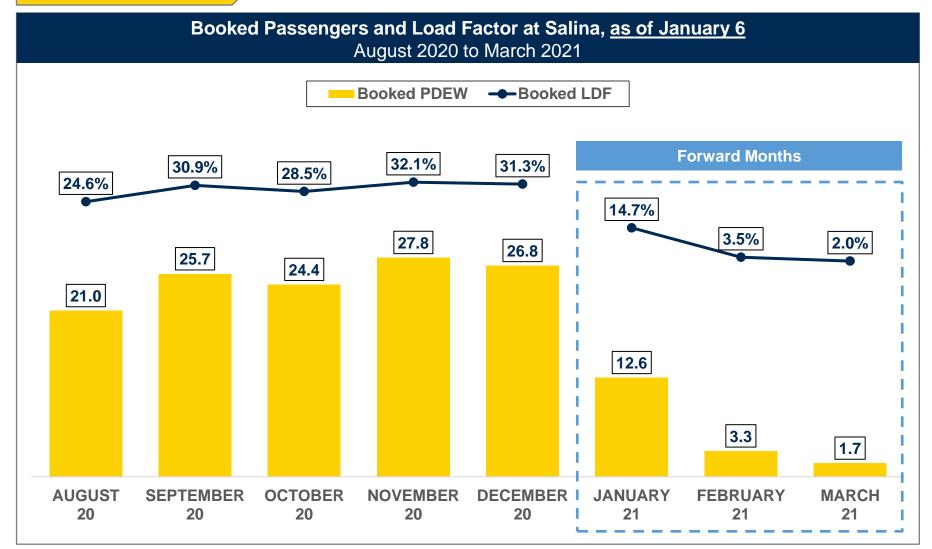

Full Year 2019 - Top 15 Markets Salina vs. Wichita

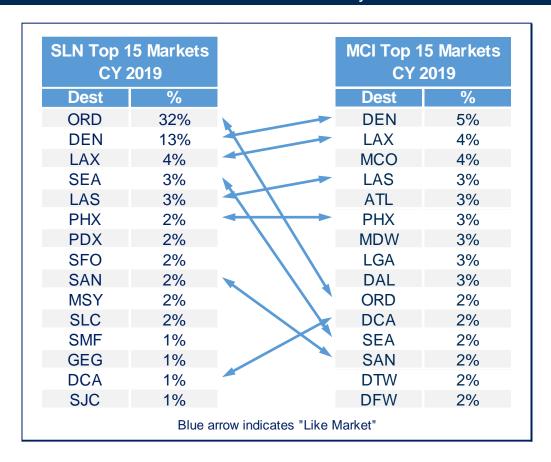

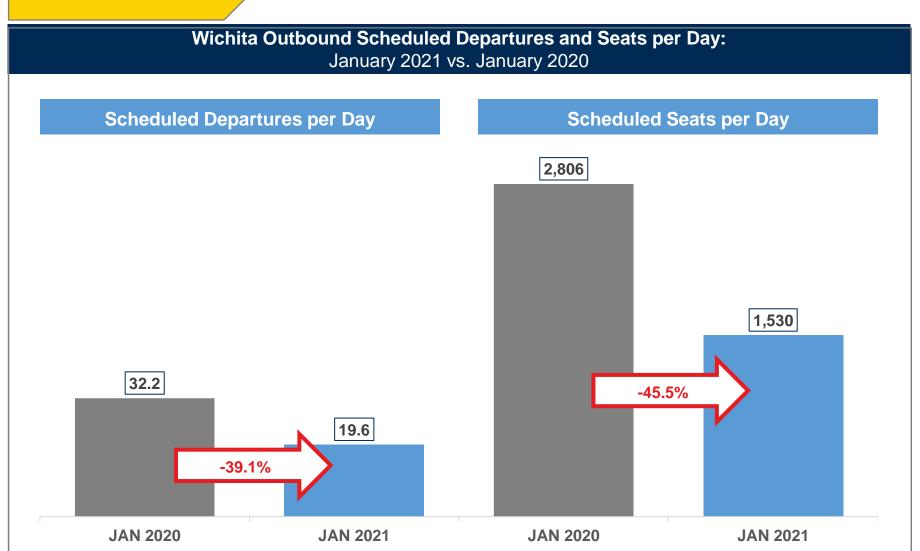
Full Year 2019 - Top 15 Markets Salina vs. Kansas City

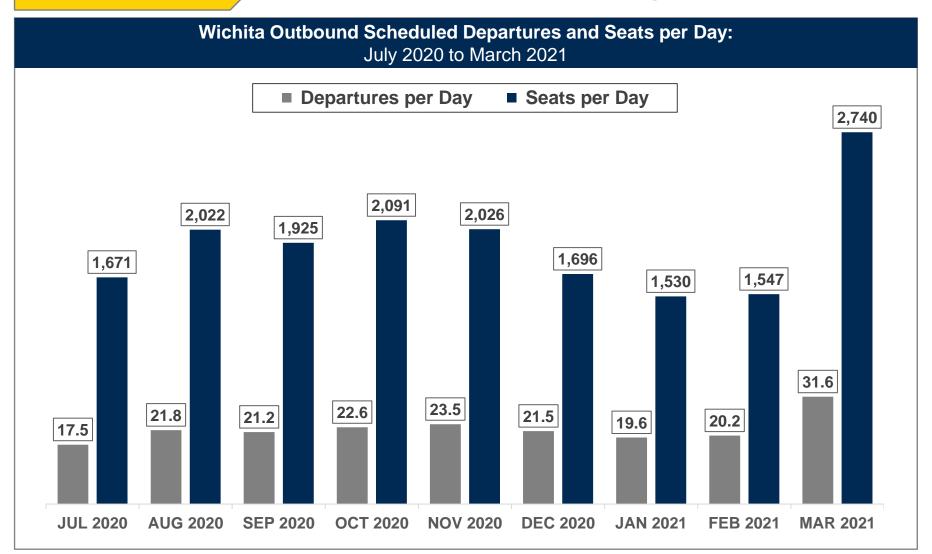

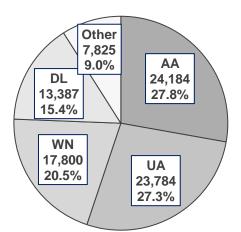

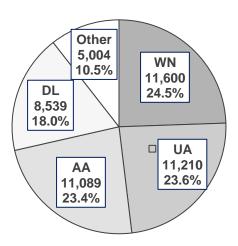

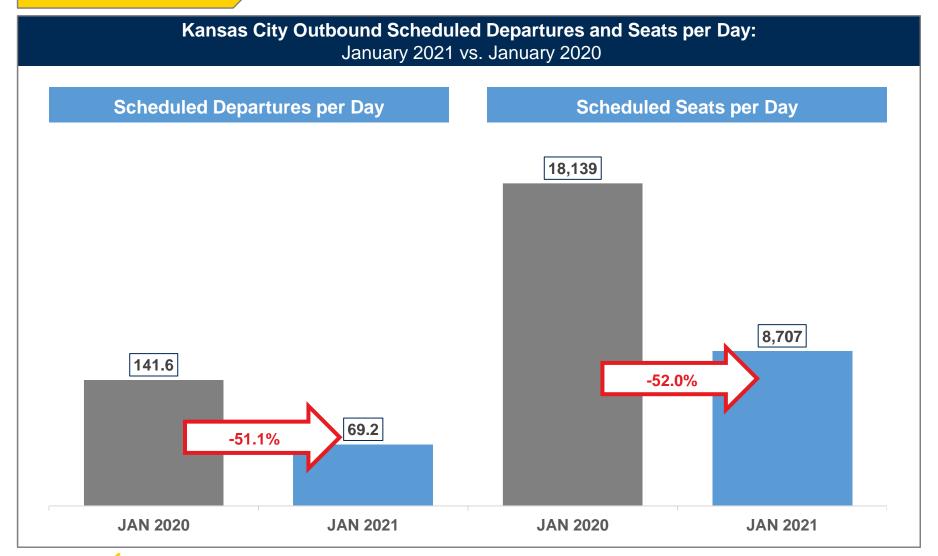

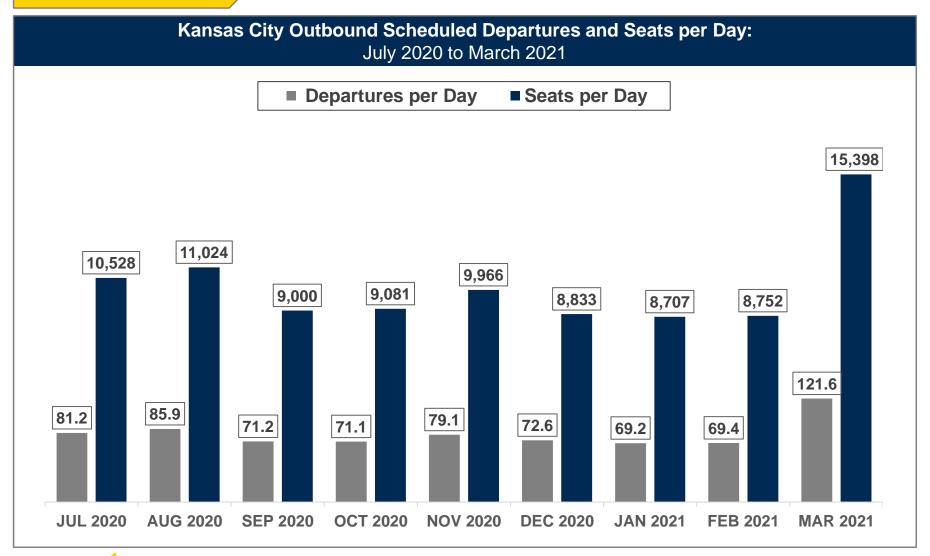

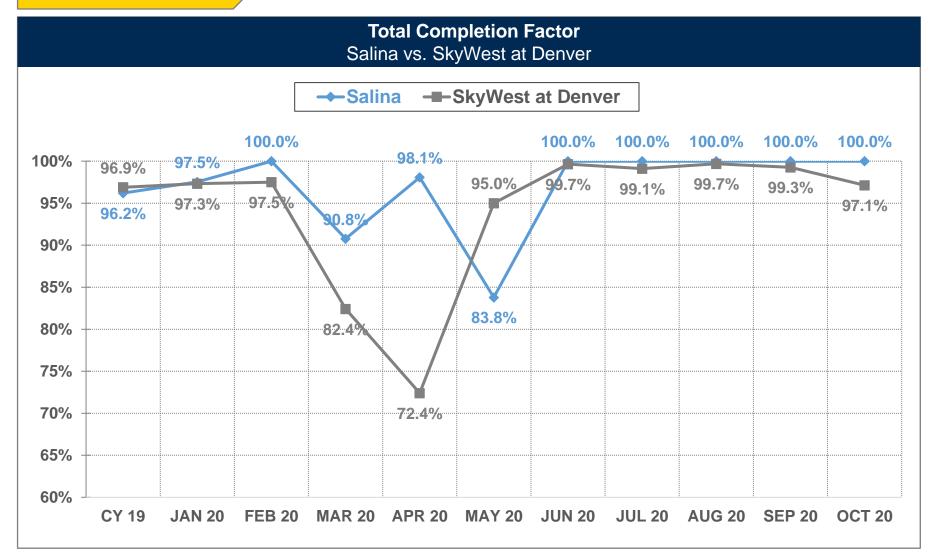

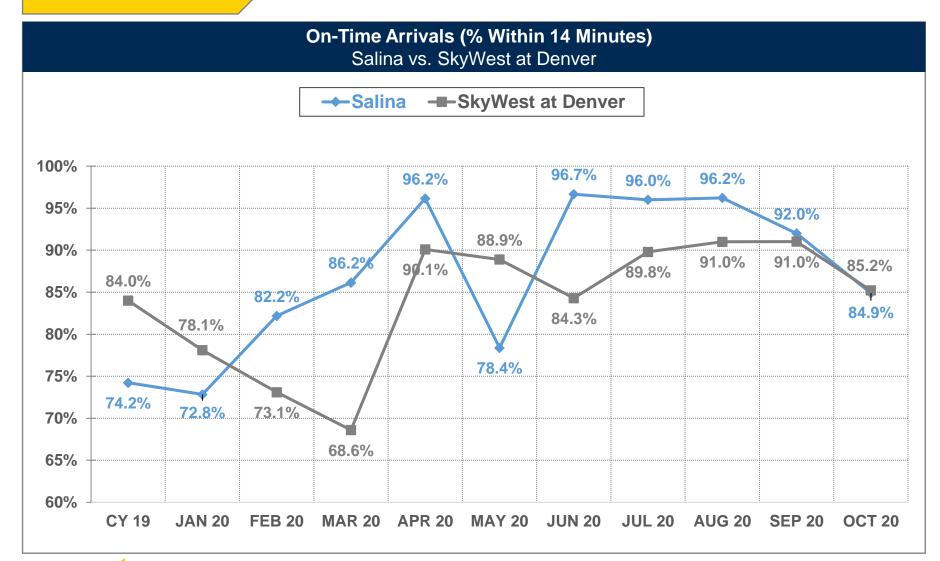

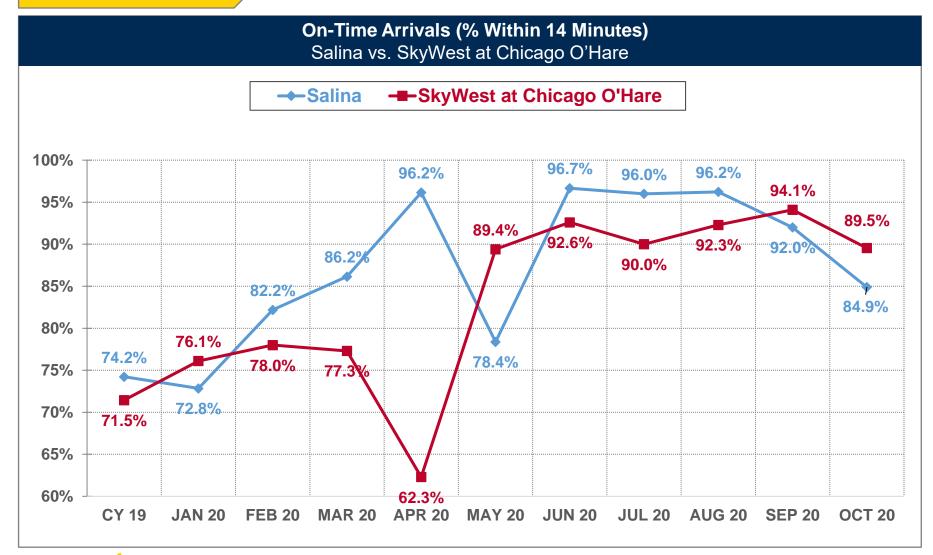


Salina fell below SkyWest at Denver from an On-Time Arrivals perspective for October



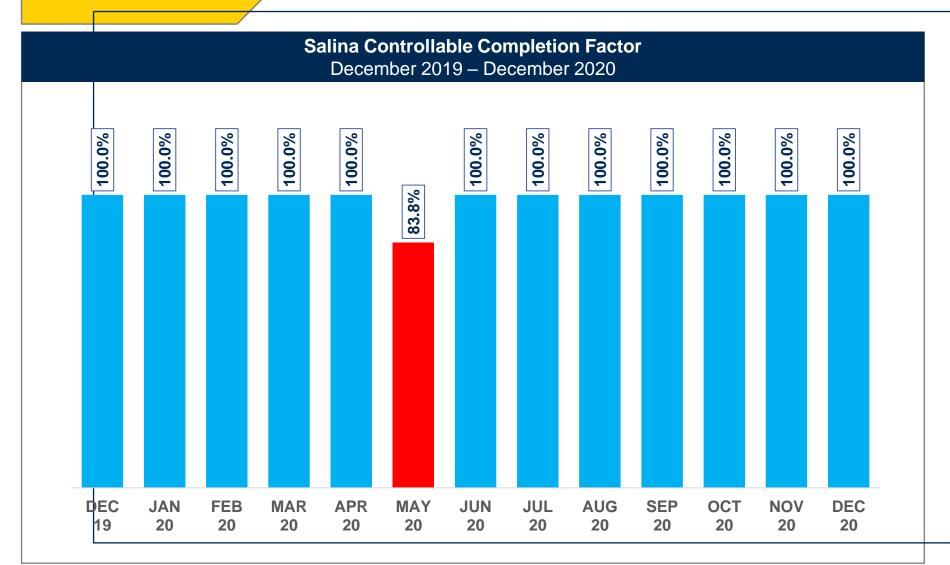

The Board of Trustees for Salina Area Technical College has reviewed the Facilities Master Plan at our September meeting of the Board of Trustees. A portion of the Facilities Master Plan document developed by Jones, Gilliam, and Renz is included for your reference. As part of the overall Facilities Master Plan, the Board reviewed the possible future expansion area south of the existing building G. We are seeking to develop a strategy to make facilities improvements for the campus.

The College currently leases approximately 23 acres and the buildings from USD 305 with an agreement to transition to ownership originally granted for September 2018. The College and USD 305 entered an extension of the lease due to the federal lawsuit between the Public entities and the USA over the environmental hazard located in the groundwater in the area. The College and USD 305 extended the lease agreement a second time and the date of expiration of the extension is June 30, 2021. Upon the expiration of the lease, the College will acquire the land and buildings in the Salina Area Technical School Addition, except for the Salina Adult Education Center and the land immediately east of that building (the land area south of Lucas Rd).

Our discussion at the September Board of Trustees meeting led to the potential acquisition of the lots 8 and 9 in the Berschel Avenue cul-de-sac. These two lots, if acquired, would provide the college with space to build a new classroom building with a parking area to accommodate future growth expected in our college. The lots are approximately 1.56 and 1.7 acres which would expand the campus by more than 3 acres on with Centennial Road frontage.

The SATC Board asked me to inquire if the Salina Airport Authority would donate the two lots to Salina Area Technical College for the purpose of future expansion. We understand that commercial lots are valuable, especially frontage on a major arterial road. We believe the current condition of the facilities on Centennial Road are in poor to fair condition. The building in the best condition is the Building E – Welding facility, which has undergone a \$1,000,000 renovation in FY 2014-15. Building F is a storage facility and maintenance shop that needs

exterior updating. Building G is in disrepair and has structural and aesthetic issues. In consideration of such donation, the College would agree to raise the building G, commonly known as "Big Blue" by December 31, 2021. The architects who developed the Facilities Master Plan in 2013 estimated the cost to raise the building at \$300,000. This expenditure has been a lower priority due to other fiscal needs and the previous lease extensions. Since the lease extensions are no longer anticipated, the College would like to move forward with the project.

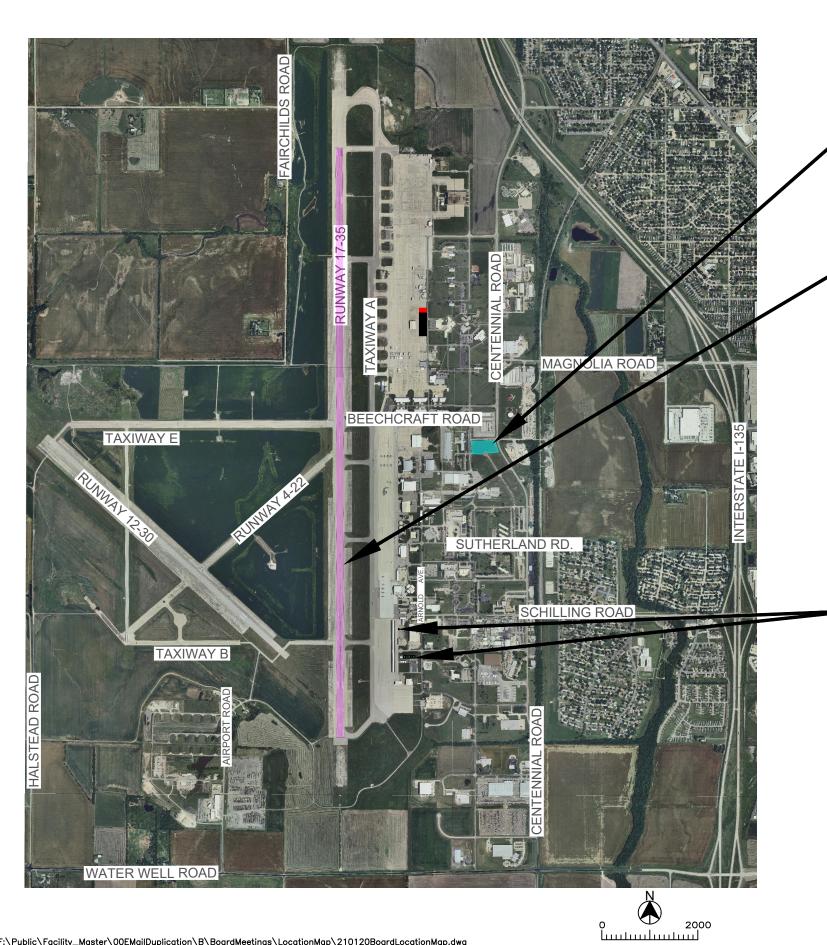

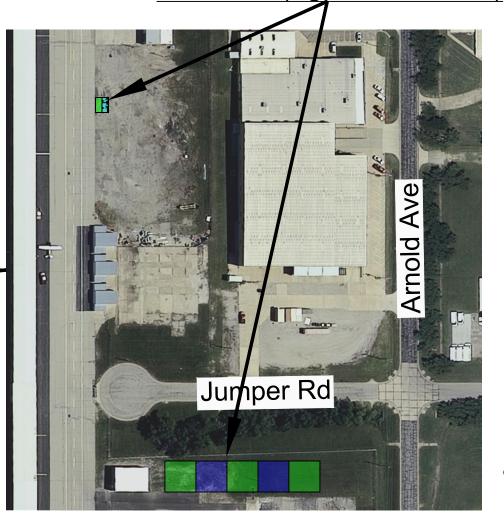
