- PPR requests will be handled during Salina Airport Authority office hours. Monday-Friday 8am-5pm (Local).
- ARFF coverage will be provided 15 minutes prior to and after scheduled arrival and departure times.
- ARFF index B/C/D/E standby coverage will be charged a flat \$950.00 fee per flight (Military and Civil).
- Early arrivals cannot be covered without 24-hour notice.
- Any early arrivals/departures of Military Flights/Charters related to Fort Riley Installation Transportation Office (ITO) must be coordinated with Ft. Riley ITO before notifying of flight schedule changes. LOC: (785) 239-8868 FROC: (785) 239-2222
- Please advise of any flight schedule changes as soon as possible. The PPR number will remain the same and is valid, unless the flight is cancelled.
- Any PPR request made less than 24 hours in advance are subject to additional fees and charges.
