MERCHANT SERVICES REVIEW

THE AUTHORITY CURRENTLY ABSORBS 100% OF CREDIT CARD PROCESSING FEES, AT AN AVERAGE EFFECTIVE RATE OF 3.45% + \$0.15 PER TRANSACTION. IN 2025, THESE COSTS ARE PROJECTED TO TOTAL APPROXIMATELY \$35,600.

Option 1 - Implement a 3% Convenience Fee on Credit Card Payments

Customers paying by credit card would be charged a 3% fee at the time of payment.

Estimated annual SAA expense savings: up to \$30,000

Option 2 – Continue Absorbing All Credit Card Fees

No fees would be passed on to the customer; the Authority continues absorbing all merchant charges.

Estimated 2025 expense: approximately \$28,600 under the Interchange-plus pricing model. Option 3 – Implement a Convenience Fee Below 3%

A lower percentage (e.g., 2% or 2.5%) could be applied to partially offset processing costs.

Estimated savings would scale accordingly.

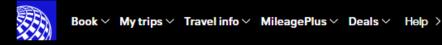
